About this document

This Target Market Determination (TMD) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). Target market statement

The Perpetual Pure Microcap Fund - Class A (Fund) is designed for consumers who:

- are seeking capital growth,
- are intending to use the Fund as a satellite allocation within a portfolio,
- · have a minimum investment timeframe of 7 years or longer,
- · have a very high or extremely high risk and return profile, and
- · are unlikely to need to access their capital within one week of request.

Investment products and diversification

This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, the SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors.
