PDS UPDATE 1 DECEMBER 2018

This document should be read in conjunction with Product Disclosure Statement issue number 5 dated 1 May 2017, including the separate Features Book, for Perpetual WealthFocus Wholesale Investment Advantage (PDS). This document:

- · updates the PDS in relation to the disclosures detailed below
- replaces the PDS update dated 1 November 2017.

Section 6 on page 7 of the PDS is replaced with the following updated information.

6. FEES AND COSTS

DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term returns.

For example, total annual fees and costs of 2% of your account balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs.

You may be able to negotiate to pay lower contribution fees and management costs where applicable. Ask us or your financial adviser.

The following information can be used to compare costs between different managed investment products.

Unless otherwise stated, all fees and costs disclosed in this PDS are inclusive of the net effect of goods and services tax (GST).

Fees and costs may be deducted from your money, from the returns on your investment or from the assets of the managed investment scheme as a whole.

The fees and costs that are charged for an investment in the Perpetual Balanced Growth investment option are shown below. Management costs vary between investment options (refer to the Features Book for details).

Additional fees may be paid to a financial adviser if a financial adviser is consulted, including a member advice fee (referred to in the separate Features Book). The fee details should be set out in the Statement of Advice provided by your financial adviser.

As an eligible investor, we will pay you a rebate of part of the management fee so that the effective net management fee that you pay is as shown in the following table.

The amounts shown in the following table include all management fees and estimated indirect costs as at the date of this PDS update. The indirect costs information is based on information available and (if applicable) estimates as at the date of this PDS update. Any updates from time to time, which are not materially adverse, will be available at our website.

- 5 These percentages are based on expense recoveries in underlying funds and other indirect costs incurred for the financial year ended 30 June 2018. - 7 This percentage is based on the underlying fund's management fee of 1.17% pa charged on its gross asset value plus the investment option's additional management fee of 0.78% pa charged on its net asset value. If the average gearing level in the underlying fund over the year is higher than 50%, the management fee will be higher than 3.12% pa of the investment option's net asset value.
- 8 This percentage is based on the underlying fund's management fee of 0.99% pa on the sum of its long and short positions plus the investment option's additional management fee of 0.96% pa on its net asset value.
- 9 Management fees for the Platinum investment options were reduced from 2.75% to 2.56% pa from 3 July 2017.
- 10 The management fee for the BlackRock Balanced investment option was reduced from 1.85% to 1.75% pa from 31 August 2017.
- 11 The management fee for the Perpetual Cash investment option was reduced from 1.05% to 0.57% pa from 31 August 2018.
- 12 The management fee rebate for the Perpetual Cash investment option was reduced from 0.35% to 0.15% pa in November 2018. However, this reduced rebate will take effect from 1 March 2019 and Perpetual is currently covering the 0.20% pa difference so the effective net fee is 0.22% pa until then.
