PDS UPDATE 14 OCTOBER 2019

This document should be read in conjunction with Product Disclosure Statement issue number 8 dated 1 March 2019, including the separate Features Book, for Perpetual WealthFocus Investment Advantage (PDS). This document updates the PDS in relation to the disclosures detailed below.

Section 6 on pages 6-7 of the PDS is replaced with the following updated information.

6. FEES AND COSTS

DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term returns.

For example, total annual fees and costs of 2% of your account balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs.

You may be able to negotiate to pay lower contribution fees and management costs where applicable. Ask us or your financial adviser.

The following information can be used to compare costs between different managed investment products.

Unless otherwise stated, all fees and costs disclosed in this PDS are inclusive of the net effect of goods and services tax (GST).

Fees and costs may be deducted from your money, from the returns on your investment or from the assets of the managed investment scheme as a whole.

The fees and costs that are charged for an investment in the Perpetual Balanced Growth investment option are shown below. Management costs vary between investment options (refer to the Features Book for details).

We may change our fees without your consent. However, we won't increase our fees, or introduce new fees, without giving you at least 30-days' written notice.

OTHER FEES AND COSTS

Additional costs apply, including transactional and operational costs. Abnormal operating expenses may also apply.

Additional fees may be paid to a financial adviser if a financial adviser is consulted, including a member advice fee (referred to in the separate Features Book). The fee details should be set out in the Statement of Advice provided by your financial adviser.
