## About this document

This Target Market Determination (**TMD**) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

## Target Market Summary

The Perpetual Select Conservative Fund (the Fund) is designed for investors who are seeking **Capital Growth and Income Distribution**, are intending to use the Fund as a **Standalone, Major allocation, Core component, Minor allocation or Satellite allocation** within a portfolio, have a minimum investment time frame of **3 Years or longer**, have a **Medium** risk and return profile for that portion of their portfolio, and are unlikely to need to access their capital within **One Week** of request in normal operating conditions.

## Instructions

## Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of minor allocation). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a balanced or moderate diversified portfolio with a minor allocation to growth assets. In this case, a product with a High risk/return profile may be consistent with the consumer's objectives for that minor allocation notwithstanding that the risk/return profile of the consumer as a whole is Medium. ## About the Fund

**Investment Objective:** The Fund aims to provide investors with long-term capital growth and income through investment in a diversified portfolio.

**Product Description:** The Fund has the following key attributes:

- It aims to outperform a composite benchmark (before fees and tax) reflecting the target allocations at any time to the various asset types, over rolling three-year periods. It also aims to outperform the CPI by 1.00% (before fees and tax) over rolling three-year periods.
- Aims to pay income on a quarterly basis given the Fund's investment universe. However, there is no guarantee that the Fund will be able to pay income in the future in any particular distribution period and the level of any income may vary materially from one distribution period to the next.

The Perpetual Select Conservative Fund provides exposure to the following asset types:

The Fund provides broad exposure across multiple asset classes. The Fund also combines specialist investment managers with different investment styles and philosophies. This can help reduce the volatility of the portfolio by avoiding over exposure to a particular specialist investment manager. As such, its portfolio diversification has been assessed as 'very high'.

**Risk Level:** The Fund's standard risk measure (SRM) is medium to high, which is reflected in the PDS. The SRM is based on industry guidance and is not a complete assessment of all forms of investment risk. The SRM is periodically reviewed and updates are communicated to investors via Continuous Disclosure. Derivatives may be used in the management of the Fund including to manage currency exposures. For more information on risks and other features of the Fund please refer to the PDS.

The Fund is most suitable for consumers who have a medium risk and return profile and:

- are seeking a Fund that has exposure to multiple asset classes,
- can accept potential losses to their capital, especially in the short-term,
- are comfortable with the specific risks associated with the Fund as disclosed in the PDS.

**Suggested Length of Investment:** The Fund may be suitable for consumers who seek to invest their capital for a minimum period of three years.

**Access to Capital:** Withdrawal requests can be made daily and must be received, verified and accepted by the Fund's unit registry prior to 3pm (Sydney time) on a Business Day to be processed using that day's exit price. If received and accepted after 3pm, it will be processed using the next calculated exit price. Proceeds from your withdrawal will typically be available within 3-5 business days but can be up to 14 business days (e.g. during distribution periods) from when we have accepted the request, given normal operating conditions. Please refer to the PDS for full details on the withdrawal conditions for the Fund and other factors that may delay or impact the payment of proceeds.

Capital Growth	The consumer seeks to invest in a product designed or expected to generate capital return over the investment timeframe. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product designed or expected to have low volatility and minimise capital loss. The consumer prefers exposure to defensive assets that are generally lower in risk and less volatile than growth investments (this may include cash or fixed income securities).
Income Distribution	The consumer seeks to invest in a product designed or expected to distribute regular and/or tax-effective income. The consumer prefers exposure to income-generating assets (this may include high dividend-yielding equities, fixed income securities and money market instruments).

<b>Consumer's Risk (ability to bear loss) and Return profile</b>	
<p>This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may use leverage, derivatives or short selling; may have liquidity or withdrawal limitations; may have underlying investments with valuation risks or risks of capital loss; or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.</p> <p>A consumer's desired product return profile would generally take into account the impact of fees, costs and taxes.</p>

Significant Dealings	<p>Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD.
