About this document

This Target Market Determination (**TMD**) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

This document is not a Product Disclosure Statement (PDS) and is not a complete summary of the product features or terms of the product. Target market statement

The Perpetual Charitable and Community Investor Fund (Fund) is operated as a non-liquid scheme. THERE IS A RISK YOU WILL HAVE DIFFICULTY WITHDRAWING YOUR INVESTMENT. INVESTORS SHOULD UNDERSTAND THEIR LIQUIDITY NEEDS AND SHOULD NOT RELY ON BEING ABLE TO ACCESS THE PORTION OF THEIR INVESTMENT PORTFOLIO THAT IS INVESTED IN NON-LIQUID ASSETS AT ALL TIMES. The ability of an investor to withdraw their capital is subject to a withdrawal offer being made. The total withdrawal volume to be made available in each redemption period is expected to be limited to 5% of the total net asset value of the Fund. Please refer to 'Withdrawals' in the 'How the Fund operates' section of the PDS for further information.

The Perpetual Charitable and Community Investor Fund is designed for income tax-exempt charitable trusts and non-profit organisations who:

- are seeking capital growth and income distribution,
- are intending to use the Fund as a solution/standalone, major, core component, minor or satellite allocation within a portfolio,
- have a minimum investment time frame of 5 years or longer,
- have a high or very high risk and return profile for that portion of their portfolio, and
- are seeking to invest in a non-liquid scheme with the ability to make monthly withdrawal requests (subject to a withdrawal offer being made) and where withdrawal proceeds are to be **paid** within 21 days from the closing date of the withdrawal offer.

Investment products and diversification

A 'Service' includes:

- Trusts, estates and agencies for which Perpetual Trustee Company Limited is a trustee, executor or attorney
- Investors who wish to access the Fund through an IDPS, IDPS-like scheme, nominee or custody service provided by Perpetual
- a Perpetual superannuation fund.

It has been determined that the distribution conditions and restrictions will make it likely that customers who purchase the product are in the class of customers for which it has been designed. We consider that the distribution conditions are appropriate and will assist distribution in being directed towards the target market for whom the product has been designed.

Review triggers

Material deviation in actual performance of the product (compared to investment objective / benchmark) over a sustained period, which may cause consumer harm.

Material change to fund liquidity which may cause consumer harm.

Material change to investment objective, key product features or fees.

Material or unexpectedly high number of complaints about the product (or distribution of the product) which indicate a systemic issue has occurred.

Significant regulatory action which indicates that the target market determination is no longer appropriate.

Where a review trigger has occurred, this target market determination will be reviewed within 10 business days.

Consumer's Risk (ability to bear loss) and Return profile	

This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, the SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may have other risk factors which result from, for example, the use of leverage, derivatives or short selling, liquidity or withdrawal limitations, may have underlying investments with valuation risks or risks of capital loss; or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.

The consumer typically prefers high growth assets (such as high conviction portfolios, hedge funds, and alternative investments).

Term Definition Consumer's need to access capital This consumer attribute addresses the likely period of time between the making of a request to access capital and the receipt of proceeds from this request under ordinary circumstances. **Distributor reporting** Significant dealings Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning. The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC. Dealings outside this TMD may be significant because: • they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or • they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer). In each case, the distributor should have regard to: • the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes). • the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and • the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer). Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if: • it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter,

- the consumer's intended product use is solution/standalone,
- the consumer's intended product use is core component or higher and the consumer's risk/return profile is low, or
- the relevant product has a green rating for consumers seeking extremely high risk/return.
