About this document

Target Market Statement

The Perpetual Pure Microcap Fund - Class A (Fund) is designed for consumers who:

- · are seeking capital growth,
- · are intending to use the Fund as a satellite allocation within a portfolio,
- have a minimum investment timeframe of 7 years or longer,
- · have a very high or extremely high risk and return profile, and
- · are unlikely to need to access their capital within one week of request.

The Fund's standard risk measure (SRM) is 6 (High), which is reflected in the Product Disclosure Statement. The SRM is based on industry guidance and is not a complete assessment of all forms of investment risk.

Specific risks associated with this fund include:

Microcap Liquidity Risk: Shares in smaller and microcap companies may trade less frequently and in smaller volumes and therefore may be affected by liquidity risk to a greater degree than share in a large companies.

Asset class concentration Risk: Investing in a fund with exposure to predominantly one asset class such as Australian shares may lead to more volatile returns than investing in a fund with a more diversified portfolio with exposure to multiple asset classes.

Drawdown Risk: The risk of a steep decline in value of an investment portfolio from a relative peak. Any time taken to recover a drawdown can vary considerably due to the nature of the underlying assets, the investment strategy, market conditions and the size of the drawdown.

Withdrawal request and acceptance frequency

Withdrawal requests can be made daily, and must be received, accepted by the Fund's unit registry prior to 3pm (Sydney time) on a Business Day to be processed using that day's exit price if received after 3pm, it will be processed using the next available price.

Proceeds from your withdrawal will typically be available within 3-5 business days but can be up to 14 business days (e.g.during distribution periods) from when we have accepted the request, given normal operating conditions.

However, the SRM is not a complete assessment of risk and potential loss.
