- 1 Except for Perpetual Cash, the full name of the managed fund is provided (including classes where applicable), which may not correspond exactly to the name of the investment option.
- 2 Except for Perpetual Cash, the SRM is applicable to the managed fund. You should refer to the product disclosure statement for a managed fund for more detailed information about risks specific to the managed fund. For Perpetual Cash the SRM applies to the investment option.
- 3 This includes administration fees and costs charged by the Pension Plan and estimated investment fees and costs and net transaction costs charged in or through the managed fund and is based on information provided by PIML. For an explanation of this amount, refer to 'Additional explanation of fees and costs' below.
- 4 The investment options' buy spreads are the Pension Plan's buy spreads as at 5 June 2026, expressed as a percentage of transactional value. All Pension Plan sell spreads are 0.00%. Refer to the PDS for further explanation of these spreads.
- 5 'Pension Plan TTR' refers to TTR accounts in the Pension Plan before the standard account based pension features have been applied (for more information, see 'Standard account based pension features to apply from age 65' within 'Our retirement income solution' in the 'Retirement income and WealthFocus' section of the PDS). Once the standard account based pension features are applied, the fees and costs for the Pension Plan will apply which are different to the fees and costs for the Pension Plan TTR.
- 6 Where the name includes ETF, while accessible via the stock exchange, this managed fund is not acquired through the exchange. Effective on and from 5 June 2026, Magellan Global Fund – Open Class Units – Active ETF was renamed to Vinva Global Alpha Fund- Active ETF to reflect a change in investment manager and investment strategy.
- 7 For MFS Global Equity Trust (the Trust), the SRM is not based on the industry guidance as referred to in the PDS. MFS considers the Trust to be high risk, suitable for investors with the ability to bear 6 or more negative returns over a 20 year period. Under the industry guidance an investment option with an expected 6 or more negative returns over a 20 year period is 7-Very high. Please refer to MFS's Target Market Determination (TMD) for further information about the risk rating.
- 8 For BlackRock Tactical Growth Fund (Fund), the SRM is not based on the industry guidance as referred to in the PDS. BlackRock considers the risk of the Fund on a scale of 1 (very low) to 7 (very high). This risk rating indicates the overall risk profile of the Fund based on the volatility of the returns and operational risk factors such as leverage, derivatives or short selling. The risk band is calculated using historical data and may not be a reliable indication of the future risk profile of the Fund. The risk band shown is not guaranteed and may change over time. The lowest band does not mean risk free.

## Additional explanation of fees and costs

The following 'Estimated ongoing annual fees and costs' tables provide estimated ongoing annual fees and costs based on the actual fees and costs for the financial year ending 30 June 2025 except for the Perpetual Cash investment option where the administration fee and investment fee applied from 10 November 2025 and the Vinva Global Alpha investment option where the investment costs applied on 5 May 2026 and the investment fee applied on and from 5 June 2026.

As can be seen below, the total annual ongoing fees and costs includes:

- administration fees and costs charged by the PensionPlan
- investment fees and costs charged in or through a managed fund
- transaction costs charged in or through a managed fund net of amounts recovered by the investment option's buy spread.

2 Estimated transaction costs depend on the managed fund(s) you choose and represent **net** transaction costs borne by all members in an investment option after any buy/sell spread recoveries charged on member transactions, which may vary from year to year. **Transaction costs should not be considered in isolation of investment returns.** It is important to understand that actively managed investments are likely to have higher transaction costs than passively managed investments, such as index funds, because of the higher expected volume of trading of the portfolio's assets in generating investment returns.

- 3 The investment fees shown for each investment option align with the net management fee charged in the managed funds accessible via the Pension Plan (ie the gross management fee charged in the unit price of the managed fund less any management fee rebate we may receive from the managed fund and pass on to members). All percentages are rounded up to two decimal places. See 'Management fee rebates' under 'Additional explanation of fees and costs' in the 'Fees and other costs' section of the PDS for further information.
- 4 The investment fee percentage for Perpetual Geared Australian Share investment option is based on the managed fund's management fee of 1.17% pa charged on its gross asset value (GAV), which equates to a management fee of 2.34% pa of the managed fund's net asset value (NAV) assuming an average gearing level of 50% in the managed fund, less the management fee rebate of 0.19% pa received from the managed fund and applied to the investment option. If the average gearing level in the managed fund over the year is lower or higher than 50%, the investment option's investment fee based on the NAV of the managed fund will be respectively lower or higher than 2.15% pa.
- 5 Performance fees may be applicable for these managed funds. Please refer to each managed fund's product disclosure statement for further details. On 5 May 2026, the performance fee was removed from the Magellan Global investment option. There is no performance fee on the Vinva Global Alpha investment option.
- 6 The investment fee percentage for Perpetual SHARE-PLUS Long-Short investment option is based on the managed fund's **management fee of 0.99% pa charged on the sum of its long and short positions (GAV)**, which equates to a **management fee of 1.39% pa** (1.386% pa rounded up to two decimal places) **of the managed fund's net asset value (NAV)** assuming the sum of its long and short positions (maximum 150%) averages 140% over the year, less the management fee rebate of 0.01% pa received from the managed fund and applied to the investment option. If the average sum of the managed fund's long and short positions over the year is lower or higher than 140%, the investment option's investment fee based on the NAV of the managed fund will be respectively lower or higher than 1.38% pa.
- 7 Effective on and from 5 June 2026, the investment fee has been reduced from 0.89% p.a. to 0.74% p.a. The investment costs are estimated to be 0.00% as a performance fee is no longer charged from 5 May 2026. The estimated total ongoing annual fees and costs have been updated accordingly.

##### Maximum allocation limit
