## About this document

This Target Market Determination (TMD) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). ## Target Market Summary

The Perpetual Diversified Growth Fund (Fund) is designed for consumers who are seeking [Capital Growth & Income Distribution](#), are intending to use the Fund as a component within a portfolio or as a whole portfolio solution, have a minimum investment timeframe of [3 Years or longer](#), have a [High](#) risk and return profile, and are unlikely to need to access their capital within [One Week](#) of request.

## About the Fund

**Investment Objective:** The Fund aims to:

- \* provide long-term capital growth and income through investment in a diversified portfolio of growth and income assets;
- \* outperform the All Groups CPI + 4.5% pa (before fees and taxes) over at least three-year periods; and
- \* outperform a composite benchmark (before fees and taxes) reflecting its allocation to the various asset types over rolling three-year periods.

**Product Description:** The Fund has the following key attributes:

- \* Designed for capital growth through a diverse mix of growth, defensive and other investments.
- \* Designed to pay income on a quarterly basis given the Fund's investment universe. However, there is no guarantee that the Fund will be able to pay income in the future in any particular distribution period and the level of any income may vary materially from one distribution period to next.

**Portfolio Diversification:** The Fund invests in a diverse mix of growth, defensive and other investments, with a focus on cash and fixed income securities. Tactical asset allocation strategies may be applied, which involves the Fund adjusting its exposure to asset classes on a regular basis within the investment guidelines.

**Asset class allocation:**

- \* Australian shares 10-35%
- \* International shares 10-30%
- \* Property 0-15%
- \* Fixed income and credit 10-55%
- \* Cash 0-30%
- \* Other investments 0-30%

As such, its portfolio diversification has been assessed as 'Very High'.

**Risk Level:** High

The Fund's standard risk measure (SRM) is 6 (High), which is reflected in the PDS. The SRM is based on industry guidance and is not a complete assessment of all forms of investment risk. Derivatives may be used in the management of the Fund including to manage currency exposures and each asset class. For more information on risks and other features of the Fund please refer to the PDS.

The Fund is most suitable for consumers who have a high risk and return profile and:

- \* are seeking a Fund that has exposure to a diverse mix of growth, defensive and other investments, with a focus on cash and fixed income securities.
- \* are comfortable with the specific risks of the Fund as disclosed in the PDS.

**Suggested Length of Investment:** The Fund is designed for consumers who seek to invest their capital for a minimum period of three years.

**Access to Capital:** Withdrawal requests can be made daily, and must be received, and accepted by the Fund's unit registry prior to 3pm (Sydney time) on a Business Day to be processed using that day's exit price if received after 3pm, it will be processed using the next available price. Proceeds from your withdrawal will typically be available within 3-5 business days but can be up to 14 business days (i.e. during distribution periods) from when we have accepted the request, given normal operating conditions. Please refer to the PDS for full details on the withdrawal conditions for the Fund and other factors that may delay or impact the payment of proceeds.
