About this document

This Target Market Determination (**TMD**) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

This document is not a Product Disclosure Statement (PDS) and is **not** a complete summary of the product features or terms of the product. Target Market Summary

The Perpetual Growth Opportunities Fund (Fund) is operated as a non-liquid scheme. THERE IS A RISK YOU WILL HAVE DIFFICULTY WITHDRAWING YOUR INVESTMENT. INVESTORS SHOULD UNDERSTAND THEIR LIQUIDITY NEEDS AND SHOULD NOT RELY ON BEING ABLE TO ACCESS THE PORTION OF THEIR INVESTMENT PORTFOLIO THAT IS INVESTED IN NON-LIQUID ASSETS AT ALL TIMES. The ability of an investor to withdraw their capital is subject to a withdrawal offer being made. The total withdrawal volume to be made available in each redemption period is expected to be limited to 1.75% of the total net asset value of the Fund. Please refer to 'Withdrawals' in the 'How the Fund operates' section of the PDS for further information.

The Perpetual Growth Opportunities Fund (the Fund) is designed for consumers who, are seeking [Capital Growth](#), are intending to use the Fund as a [Minor or Satellite allocation](#) within a portfolio, have a minimum investment time frame of [5 Years or longer](#), have a [High](#) or [Very High](#) risk and return profile for that portion of their investment portfolio, and have a potential need to access capital that allows them to invest in a non-liquid scheme with the ability to make quarterly withdrawal requests (subject to a withdrawal offer being made) and where withdrawal proceeds are to be paid up to 21 days after the withdrawal offer closing date to which the monthly withdrawal offer relates to.

Investment products and diversification

About the Fund

Investment Objective: The Fund aims to provide investors with long-term capital growth through investment in a diversified portfolio of private equity funds, infrastructure funds, opportunistic property funds, absolute return funds and other investments consistent with the Fund's investment approach.

Product Description: The Fund has the following key attributes:

- The Fund is a non-liquid managed investment scheme.
- It aims to outperform the Bloomberg AusBond Bank Bill Index over rolling five-to-seven-year periods by 3% per annum.
- It aims to pay income on an annual basis given the Fund's investment universe. However, there is no guarantee that the Fund will be able to pay income in the future in any particular distribution period and the level of any income may vary materially from one distribution period to next.
- It is a portfolio of Australian and international opportunistic growth investments that have a low correlation to listed equity markets.

Portfolio Diversification: The Perpetual Growth Opportunities Fund provides exposure to a diversified portfolio of private equity funds, infrastructure funds, opportunistic property funds, absolute return funds and other investments consistent with the Fund's investment approach.

These investments are made in a diverse mix of assets, either directly or indirectly via underlying managed funds. As such, its portfolio diversification has been assessed as high. The Fund is an illiquid scheme and is most suitable for up to 25% of the consumer's investable assets.

Risk Level: The Fund's standard risk measure (SRM) is high, which is reflected in the PDS. The SRM is based on industry guidance and is not a complete assessment of all forms of investment risk. The SRM is periodically reviewed and updates are communicated to investors via Continuous Disclosure.

Derivatives may be used in the management of the Fund. Specific risks associated with this Fund include liquidity risk as the Fund is classed as illiquid, with periodic withdrawal offers expected to be made available to investors. Additional risks include prime broker risk, gearing risk, short-position risk, valuation risk and differential performance risk.

The Fund is most suitable for consumers who have a high to very high risk-return profile and:

- are seeking a fund that has exposure to a diversified portfolio of alternative growth assets,
- are seeking capital growth,
- can accept potential losses to their capital, especially in the short-term,
- do not require regular liquidity of less than two months, and
- are comfortable with the specific risks associated with the Fund as disclosed in the PDS.

Suggested Length of Investment: The Fund may be suitable for consumers who seek to invest their capital for a minimum period of five years.

Access to Capital: Withdrawals from the Fund can only be made subject to a withdrawal offer by Perpetual according to the Corporations Act while the Fund is non liquid. Investors need to assess their own liquidity needs and should not rely on being able to access the portion of their investment portfolio that is invested in non-liquid assets at all times. In this case, we are under no obligation to make withdrawal offers, However, we generally expect to make withdrawal offers monthly, seeking to offer 1.75% of the total net asset value of the Fund and subject to available cash. Unless the withdrawal offer is cancelled, if our Sydney office receives and accepts a withdrawal request by 3pm on a withdrawal offer closing date, it will be processed within 21 days using the exit price calculated for the last calendar day of the month to which the monthly withdrawal offer relates. If the value of all withdrawal requests received exceeds the amount offered for withdrawal in a particular month, all requests received will be met on a pro rata basis. Any unpaid amounts will not be carried over to the next month and you would need to lodge another withdrawal request for that month if you still wish to withdraw an unpaid amount from a previous month. Consumer's investment objective	
Capital Growth	The consumer seeks to invest in a product designed or expected to generate capital return over the investment timeframe. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product designed or expected to have low volatility and minimise capital loss. The consumer prefers exposure to defensive assets that are generally lower in risk and less volatile than growth investments (this may include cash or fixed income securities).
Income Distribution	The consumer seeks to invest in a product designed or expected to distribute regular and/or tax-effective income. The consumer prefers exposure to income-generating assets (this may include high dividend-yielding equities, fixed income securities and money market instruments).
Consumer's intended product use (% of Investable Assets)

Consumer's Risk (ability to bear loss) and Return profile	
This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may use leverage, derivatives or short selling; may have liquidity or withdrawal limitations; may have underlying investments with valuation risks or risks of capital loss; or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating. A consumer's desired product return profile would generally take into account the impact of fees, costs and taxes.	
Low	For the relevant part of the consumer's portfolio, the consumer: • has a conservative or low risk appetite, • seeks to minimise volatility and potential losses (e.g. has the ability to bear up to 1 negative return over a 20 year period (SRM 1 to 2)), and • is comfortable with a low target return profile. The consumer typically prefers stable, defensive assets (such as cash).
Medium	For the relevant part of the consumer's portfolio, the consumer: • has a moderate or medium risk appetite, • seeks low volatility and potential losses (e.g. has the ability to bear up to 4 negative returns over a 20 year period (SRM 3 to 5)), and • is comfortable with a moderate target return profile. The consumer typically prefers defensive assets (for example, fixed income).
High	For the relevant part of the consumer's portfolio, the consumer: • has a high risk appetite, • can accept high volatility and potential losses (e.g. has the ability to bear up to 6 negative returns over a 20 year period (SRM 5 or 6)), and • seeks high returns (typically over a medium or long timeframe). The consumer typically prefers growth assets (for example, shares and property).
Very High	For the relevant part of the consumer's portfolio, the consumer: • has a very high risk appetite, • can accept very high volatility and potential losses (e.g. has the ability to bear 6 to 7 negative returns over a 20 year period (SRM 6 or 7)), and • seeks to maximise returns (typically over a medium or long timeframe). The consumer typically prefers high growth assets (such as high conviction portfolios, hedge funds, and alternative investments).
Extremely High	For the relevant part of the consumer's portfolio, the consumer: • has an extremely high risk appetite, • can accept significant volatility and losses, and • seeks to obtain accelerated returns (potentially in a short timeframe). The consumer seeks extremely high risk, speculative or complex products which may have features such as significant use of derivatives, leverage or short positions or may be in emerging or niche asset classes (for example, crypto-assets or collectibles).

This consumer attribute addresses the likely period of time between the making of a request for redemption/withdrawal (or access to investment proceeds more generally) and the receipt of proceeds from this request under ordinary circumstances.

Distributor reporting	
Significant Dealings	Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning. The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC. Dealings outside this TMD may be significant because: • they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or • they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer). In each case, the distributor should have regard to: • the nature and risk profile of the product (which may be indicated by the product's risk rating or access to capital timeframes), • the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and • the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer). Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if: • it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter, • the consumer's intended product use is solution/standalone, • the consumer's intended product use is core component or higher and the consumer's risk/return profile is low, or • the relevant product has a green rating for consumers seeking extremely high risk/return.
