INVESTMENT APPROACH

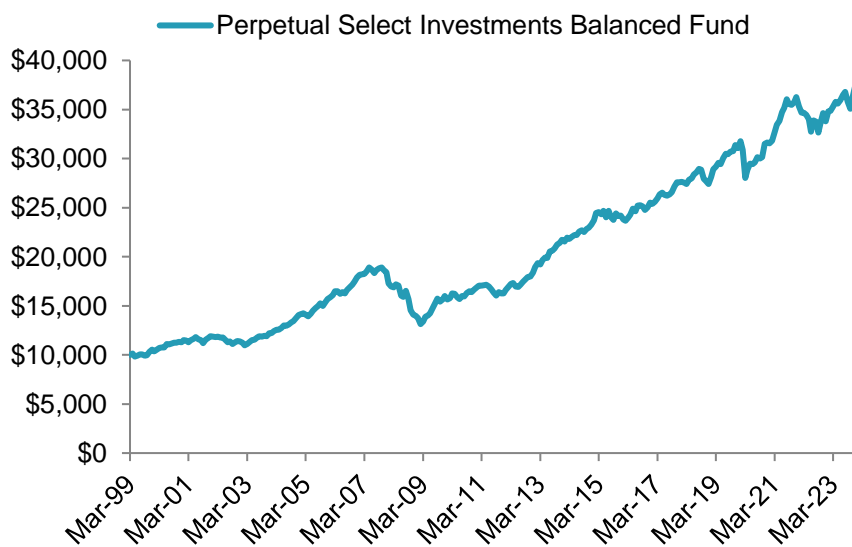

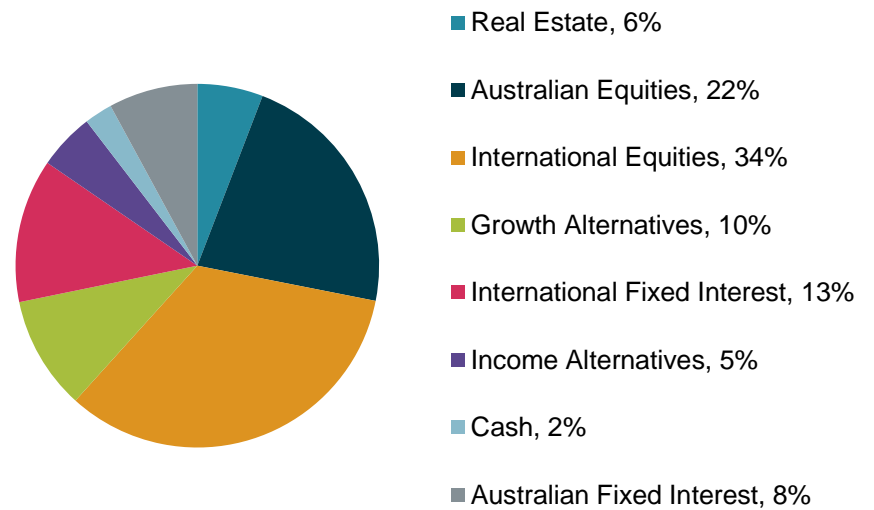
