- · a registrar or deputy registrar of a court
- · a Justice of the Peace
- a person enrolled on the roll of a State or Territory Supreme Court or the High Court of Australia, as a legal practitioner
- · an Australian consular officer or an Australian diplomatic officer
- · a judge of a court
- · a magistrate, or
- a Chief Executive Officer of a Commonwealth court


