## PDS UPDATE - FEES AND COSTS

Pages 11-13 of the PDS are updated with respect to the following disclosures.

## Fees and costs applicable from 28 November 2019

The estimated 'Investment fee' and estimated 'Indirect cost ratio' percentages shown in the table on page 11 of the PDS have decreased.

Following the recent transfer of inactive low-balance accounts to the Australian Taxation Office (refer 'Transfer of inactive low-balance accounts to the ATO' on page 4 of the PDS for further information), from 28 November 2019 the estimated total annual fees and costs:

- for each of AERF Sub-Plans A, B, M and REST have decreased; and
- are now the same for all AERF Sub-Plans.

  - 0.000% for performance-related fees, which may be incurred indirectly in underlying funds used to manage the AERF's alternative investments where the underlying fund exceeds its performance hurdle and meets any other relevant conditions for a defined period of time
  - 0.451% for other indirect costs.

## Example of fees and costs applicable from 28 November 2019

As a consequence of the above changes, the four separate examples for each of AERF Sub-Plans A, B, M and REST on pages 12-13 of the PDS are deleted and replaced with the following single example, which is now applicable to all AERF Sub-Plans.
