Ongoing annual fees and costs

The total ongoing annual fees and costs for each Fund comprises:

- · management fees and costs
- · any applicable performance fees
- · transaction costs.

The estimated ongoing annual fees and costs shown in the current PDS include management fees, estimated management costs, estimated performance fees and estimated transaction costs (based on the previous financial year ended 30 June 2020) as at the date of the PDS. The following table provides updated estimated ongoing annual fees and costs based on updated estimated management costs, updated estimated performance fees and updated estimated transaction costs reflecting the latest completed financial year ended 30 June 2022.

Ongoing annual fees and costs may vary in future years.

- 1 Estimated alternative asset fees are based on those charged for the financial year ended 30 June 2022, which may vary in future years. A Fund's actual exposure to alternative assets and the relative allocations between their various underlying specialist investment managers, charging differing amounts in varying ways, will impact the total alternative asset fees charged each year.
- 2 Estimated other management costs are based on management costs (including any indirect costs associated with investing in the underlying funds and any relevant derivatives) for the financial year ended 30 June 2022, which may vary in future years.
- 3 Estimated performance fees are based on average annual performance fees charged by relevant specialist investment managers for the previous five financial years ended 30 June 2022. **Performance fees should not be considered in isolation of investment returns. Past performance and these estimates are not indicative of future returns.** Performance fees payable in the future may vary depending on:

- the portions of a Fund's assets that are subject to performance fees
- a Fund's allocation between the relevant specialist investment managers, charging differing performance fees against varying outperformance benchmarks
- $\hbox{- the actual investment returns each specialist investment manager achieves}.$
- For Perpetual Select Conservative Fund, the performance fee for the financial year ended 30 June 2022 was 0.23%.
- For Perpetual Select Diversified Fund, the performance fee for the financial year ended 30 June 2022 was 0.29%.
- For Perpetual Select Balanced Fund, the performance fee for the financial year ended 30 June 2022 was 0.32%.
- For Perpetual Select Growth Fund, the performance fee for the financial year ended 30 June 2022 was 0.35%.
- For Perpetual Select Australian Share Fund, the performance fee for the financial year ended 30 June 2022 was 0.27%.
- For Perpetual Select International Share Fund, the performance fee for the financial year ended 30 June 2022 was 0.16%.
- 4 Estimated transaction costs represent **net** transaction costs borne by all investors in a Fund after any buy/sell spread recoveries charged on investor-initiated transactions for the financial year ended 30 June 2022, which may vary in future years. **Transaction costs should not be considered in isolation of investment returns.** It is important to understand that actively managed investments are likely to have higher transaction costs than passively managed investments, such as index funds, because of the higher expected volume of trading of the portfolio's assets in generating investment returns.
