Invests into a diverse mix of assets (see 'Investment guidelines' below). Derivatives and exchange traded funds may be used in managing each asset class.

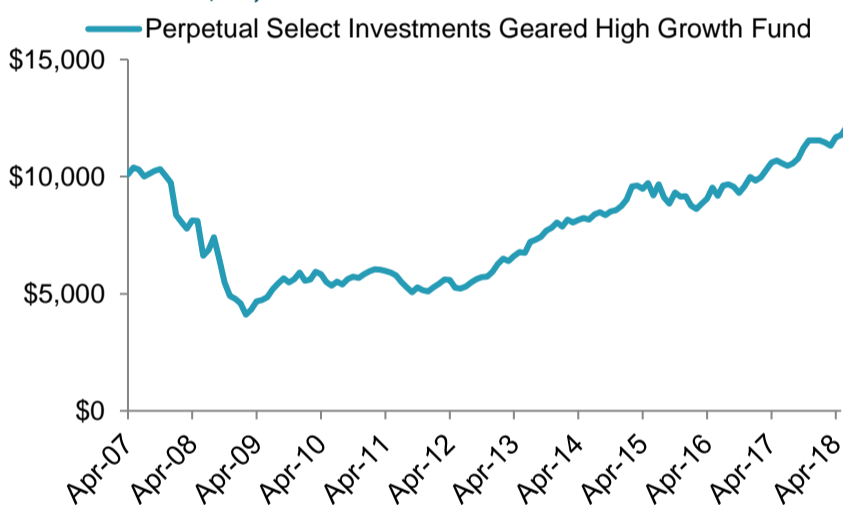

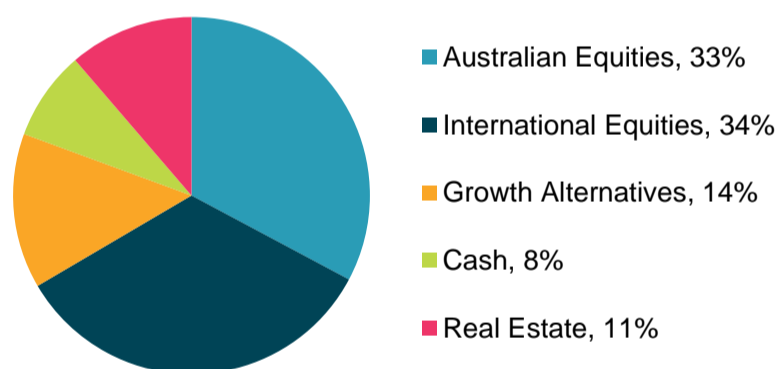
