



# 2019 IMPACT CAPACITY GRANT PROGRAM – FAQs

## OVERVIEW

### Q. What is the IMPACT Capacity Grant Program?

**A.** Our IMPACT Philanthropy philosophy combines a strategic approach to philanthropy with sustained support for the NFP sector. At Perpetual we are committed to encouraging philanthropy that supports non-profit organisations who demonstrate a strong focus on **Leadership, Capability, Strategy and Outcomes** in their sectors.

The IMPACT Capacity Grant Program will see outstanding organisations nationally invited to apply for the opportunity of a \$600,000 grant (over three years) to help them increase their community impact.

### Q. Why has my organisation been invited to apply?

**A.** Perpetual has identified your organisation as a consistent high performer in our assessment process and considers your organisation to demonstrate excellence in the areas of governance, including strategy, capability, leadership and outcomes.

### Q. How were organisations chosen to be invited for the IMPACT Capacity Grant Program?

**A.** A selection of top performing organisations (over a period of three years) from each of the states that do not fall into the Health and Medical Research area were invited to apply.

Health and Medical Research programs received significant support from Perpetual clients. The Perpetual Philanthropy Team will work with clients to identify and invite longer terms submissions from high performing organisations working in that area.

## FUNDING

### Q. How does my organisation submit an application to the 2019 IMPACT Capacity Grant Program?

**A.** The process of applying to the Capacity Grant Program is the same as the applying for funding through the general IMPACT Philanthropy Application Program. The online application form can be accessed from our [website](#) during the period that applications are open – from **9am AEDT on Monday 29 October 2018 and close 5pm AEDT on Friday 7 December 2018**. Only organisations who have been invited to apply are eligible for an IMPACT Capacity Grant Program grant.

### Q. What kind of project should be submitted for consideration?

**A.** We encourage organisations to apply for support that may improve outcomes for community, better your performance as an organisation, and increase your capacity to deliver your work to more communities or engage with new technologies.

Retrospective funding (for initiatives that have already taken place), fundraising appeals or funding direct to individuals are not eligible.

**Q. What is the chance of us securing funding through the IMPACT Capacity Grant Program?**

**A.** All organisations invited into the IMPACT Capacity Program will have a 40% chance of securing funding as long as your application ranks well through our assessment process.

**Q. How much should our organisation apply for?**

**A.** Your organisation is invited to apply for one grant of up to \$200,000 per year for a period up to three years.

**Q. If we apply for an IMPACT capacity grant, are we still eligible to apply for a grant through Perpetual's general IMPACT Philanthropy Application Program?**

**A.** Your invitation to apply for a grant through the Capacity Grant Program does not limit your ability to apply through our general process and does not count towards the number of submissions your organisation can make.

## **TIMELINE AND PROCESS**

**Q. When does Perpetual accept applications for the 2019 IMPACT Capacity Grant Program?**

**A.** Applications open at **9am AEDT on Monday 29 October 2018 and close 5pm AEDT on Friday 7 December 2018**. We only accept applications during this period via our online system. No extensions will be granted.

**Q. When will my organisation be notified of the outcome of our application?**

**A.** We will notify all organisations of the outcome in the last week of June 2019 via the applicant's email address.

**Q. Is the acquittal process different for IMPACT Philanthropy Partnership grant recipients?**

**A.** The requirement to provide an acquittal report is the same as the general IMPACT Philanthropy Application Program. The acquittal process is found on our website. Go to [www.perpetual.com.au/IMPACT-Philanthropy](http://www.perpetual.com.au/IMPACT-Philanthropy)
