- 3 These amounts are additional to the fees and costs we charge. They are generally incurred indirectly and reflected in the unit prices of the underlying funds.

- 8 For the Perpetual Cash investment option, from 1 October 2019:
 - the management fee was reduced from 0.57% to 0.42% pa
 - the management fee rebate paid to eligible investors was reduced from 0.15% to 0.00% pa.

This means that the management fee for the Perpetual Cash investment option from 1 October 2019 became 0.42% pa for all investors.

The management fee was further reduced from 0.42% to 0.22% pa from 15 June 2020.

The percentages shown represent the weighted annual average management fee and management fee rebate.

- 9 This percentage is based on the underlying fund's management fee of 1.17% pa charged on its gross asset value plus the investment option's additional management fee of 0.78% pa charged on its net asset value. If the average gearing level in the underlying fund is 50%, the management fee will be 3.12% pa of the investment option's net asset value. If the average gearing level in the underlying fund over the year is higher than 50%, the management fee will be higher than 3.12% pa of the investment option's net asset value.
- 10 This percentage is based on the underlying fund's management fee of 0.99% pa on the sum of its long and short positions plus the investment option's additional management fee of 0.96% pa on its net asset value.
- 11 The management fee for the Aspect Diversified Futures investment option was reduced from 2.62% to 2.32% pa from 26 June 2020. The percentage shown represents the weighted annual average management fee.
