



## PERPETUAL WHOLESALE FUNDS

The following incorporated information forms part of Product Disclosure Statement issue number 12 dated 25 November 2019 (PDS) for Perpetual Wholesale Funds (Funds) and should be read in conjunction with the PDS.

### TRANSACTIONAL AND OPERATIONAL COSTS
