Perpetual's Board has noted the letter from Australian Institute of Company Directors (AICD) in relation to the AICD 30% Club and resolved to support the initiative.

At this time Perpetual has 29% female representation on the Perpetual Limited Board. Our resolution to achieve 30% representation therefore remains in place.

In addition, Perpetual's D&I policy states that to promote gender equality in recruitment, at least one female is included for consideration for any Board appointments and at least one woman forms part of the interview and selection panel for these appointments.

In addition, Perpetual's Board has established a measurable gender diversity objective to achieve 40% representation of women in senior leadership roles by 2020. This goal includes appointments for any governing bodies (or Board subsidiaries) over which Perpetual has control.

Perpetual is acutely aware of the GPG challenge for our industry, and in turn has responded by conducting annual GPG reviews.

In 2018 a full GPG review was completed by:

1. Like-for Like roles
2. By level (using WGEA categories)
3. Organisation Wide

In 2018, the review found a reduction in Perpetual's organisation wide GPG (GEC), which improved 3.7 percentage points from the previous year. This was due to an increase in female promotions and hires into senior roles.

In addition, in 2018 a GPG review was under taken for starting salaries for all new hires over the preceding 12 months. Of the 174 hires in FY18, the GPG was -1.05% for females when compared to males.

With a market cap of \$1.49 Billion and approx. 968 employees, Perpetual has made a significant investment and demonstrated its ongoing commitment to improving its gender equality outcomes - both in absolute terms and relative to our peer group. In 2018/19 a number of strategies were employed to increase engagement and accountability of gender equality at Perpetual.

Highlights include:-

1. Embedding Women in Leadership targets into Divisional Scorecards (7 point uplift achieved since targets were introduced in 2017)
2. In recent CEO transition, inducting our new CEO into the Chair position for our Perpetual Diversity Council
3. Appointing a new D&I Executive Committee Sponsor for FY2019 (Group Executive, Perpetual Investments) to champion D&I, and gender equality in a key area of focus – our investment management division
4. Continued focus on inclusive leadership development to build awareness and capability in our leadership cohort and help us progress the gender equality conversation
5. Continued participation in annual WiBF Mentoring for Success Program, since 2012 Perpetual has sponsored 35 female Mentees through the program to fast-track their development
6. Continued investment in Perpetual's Inspiring Women's Forum to provide networking opportunities, inspiring keynote speakers and development opportunities for our female talent
